Keynote Speaker Presentation

Jim Ostrom

Partner, President & CEO, Milk Source, LLC Topic: Large Scale and Sustainable



Jim Ostrom is a man on a mission: a mission to create a dairy company recognized as an industry leader in sustainability.

Mr. Ostrom, along with his business partners John Vosters and Todd Willer, has passionately pursued that vision for 20 years. During this time, Milk Source LLC has evolved from a single 180-cow dairy into a multistate family of eight large farms in three states. The company produces more than a quarter million gallons of milk every day- enough to provide 2 million households with a gallon every week.

This level of success offers a testament to Milk Source's vision that sustainability is based on the meaningful care of people, animals and natural resources. More than 550 employees know Jim's mantra that the single-most-important person in the company is the newest, least-experienced employee. Leadership and skills training provide immediate mentorship in critical job skills and stewardship values.

Milk Source believes that excellence is something to be pursued but never truly achieved. "Good enough" is never good enough. Jim's drive to reach the next horizon, and the horizon after that, has not only bolstered the company's fortunes, but also its credibility. In 2014 alone, Milk Source was named the nation's Innovative Dairy Farm of the Year; Wisconsin Manufacturers & Commerce's Business Friend of the Environment; and one of three finalists for Wisconsin's Leopold Conservation Award.

Jim and his wife, Annette, co-founded Dairy Cares of Wisconsin, a non-profit organization that has raised more than \$360,000 for Children's Hospital of Wisconsin. In addition, Milk Source donates regularly to food pantries in its home communities. While philanthropy is important, Jim remains a hard-core realist. He understands that in a world of consumers increasingly disconnected from food production dairymen must tell their own stories, or the skeptics and cynics will dictate the conversation. And, he knows that spreading the gospel of socially responsible farming means investing time out of the office. Jim remains one of the longest-serving board members of the Wisconsin Dairy Business Association, advocating vigorously for his entire industry.

Perhaps more importantly, Milk Source is not afraid to open its doors. An average of 10,000 visitors a year tour the various Milk Source Dairies and Farms, allowing its farmers and herdsmen to demystify modern agriculture and shatter myths about how animals and crops are shepherded. Guests from all 50 states and five continents have made a pilgrimage to a Milk Source Farm.

Jim holds a Bachelor of Science Degree in Agricultural Economics from the University of Wisconsin-Madison and has continued his professional development via Harvard University Business School's Agribusiness Program for Executives.
